Jim has had a bad time with shortness of breath for over a month now. He was hospitilized in November for seven days. They run lots of tests to see what was causing the problem, the doctors kept telling us that it was not the cancer. One month later we went back to have another Bronchoscope done and they took a biopsy of the right lung and on Friday told us that the cancer had invaded the right lung also. Needless to say we were devastated over the news. It is very hard for him to walk just around the house and it takes all of his breath to move about. The cancer doctor wants to try another type of treatment on the 27th of December, but we need to build up the blood platelets some more. Right now he is scheduled for a procrit shot again next Wednesday and then another ct scan then we will be able to start Chemo again.

A Young Glenn Moe

My husband, Glenn A. Moe, of Company I 502nd Parachute Reg., died July 16, 2001 at a local Care Center, due to throat blockage and fluid buildup in his lungs.

Glenn was in the U.S. Army during WWII from January 1942 until October 1945, serving as a Paratrooper in Company I, 502nd Parachute Regiment. He participated in the D-Day

Invasion of Normandy, the Holland Invasion, Battle of the Bulge, and Berchtesgaden. Glenn was wounded twice and received the Bronze Star Medal with Oak Leaf Cluster, and the Purple Heart Medal.

In civilian life Glenn was a Fur Trapper and Gold Miner and worked as a Sheet Metal Journeyman. He belonged to the 101st Airborne Division Ass'n., Disabled American Veterans, Veterans of Foreign Wars, The Bethlehem Lutheran

Church and the Laborers for Christ.

Glenn loved to fish, hunt, golf andgarden. He was an inveterate tinkerer who fix almost anything. After his retirement he helped "Laborers for Christ" and worked on three churches in Texas and Montana. Glenn told great stories about growing up in Montana during the great depression, and surviving the battles in WWII. Although Glenn was a decorated war hero, he was a modest and quiet man. He was patient, with a kind and gentle spirit. Glenn loved his family and friends and will be sorely missed by those who loved him.

At Glenn's funeral, after the minister did the service, his grandchildren

and friends spoke of their best memories with Glenn.

### THE NEW AIRBORNE AND SPECIAL OPERATIONS MUSEUM

The new Airborne and Special Operations Museum in Fayetteville, North Carolina is housed in a beautiful building and is laid out in chronological order from 1940 up to the current date. The Museum is an avesome structure, it is a 59,000 square foot facility which houses a hanging C-47 Airplane, a Waco Glider with a Jeep inside, a helicopter, and a tank, among many other authentic wartime artifacts.

Dioramas of some military operations are displayed and are very well done to the point where you find yourself talking to manikins. The complete tour through the museum is accessible to the handicapped and will take as much time as you wish to spend, but I would say about two hours for someone who was in WWII. It is easy to get to, especially if one has been at Fort Bragg. You just continue to Fayetteville on Bragg Boulevard about four or five miles and just before you reach Hay St. there is a light which guides you to

the left to enter the free parking lot for the museum.

MUSEUM FACTS:-Where - 100 Bragg Boulevard, Fayetteville, N. Carolina. Hours - 10am to 5pm Tuesday to Saturday - Noon to 5pm on Sunday - Closed Mon. Cost - Admission is FREE, Movie on the History of the Airborne, @ Special Operations Soldiers \$3. - Ride in a simulator (Parachuta Jump) \$3. Parking - The Museum has 150 spaces that can be reached from Hillsboro or Water St. SIZE - The Museum and it's grounds cover nearly seven acres. The Museum spans 59.000 square feet. About 300 objects are on display.

Through the internet technology, I've been in touch with some great people who've helped me find out more about my brother, Lester A. Taylor, who was KIA on Sept. 19, 1944 in Operation Market Garden near Best, Holland. At that time, I was 5 years old. I have very little real memory of him, but he has been my hero all these years. Our parents were farmers in Tennessee. Lester wanted very much to get back home and establish himself on a farm. He was married a short time before going overseas and had no children.

An older sister, Lola, was in touch with Lester's friends in Company I. Their names are enclosed. Lola would be so happy to know I've found you and the other contacts that have been made recently. She died of cancer in 1988. We were a large family of 4 boys and 5 girls raised on a small Tennessee farm.

I talked with Bob Tripp on the phone this morning. Great conversation... he told me his memories of Lester's death that he had heard, since Lester was the squad leader...he added to Champ Baker's information that Lester took a route through a house to reach the others, there were Germans inside, they had a shoot out, Lester came out of the door fatally wounded with a live grenade in his hand which he tossed away before he died right there.

I look forward to receiving pictures from Bob and will send him some of my information. Bob recommended I talk to you, to which I could tell him that we had already talked...my thanks to you all. I'm anxiously waiting to receive the Poopsheet. I plan to share all this with my family as they are very excited also. It's really sad that it has taken so long to find you.

Here are the names of Lester's friends who wrote to my sister Lola, in 1944. John P. Lachkovic - Lt. Robert G. Burns - Sgt. Paul Cooney - Cpl.Glenn Moe - Capt. Champ L. Baker. Lester's remains were returned to the States just before Easter, 1948. He is buried beside his Mom and Dad at Loretto, TN. EDITOR'S NOTE: I retyped these letters so theycould be more easily read by us who can't see as clearly as we used to.

## OAK LEAF CLUSTER TO THE BRONZE STAR MEDAL

Corporal Lester Taylor distinguished himself by heroic achievement in action. On June 6, 1944, he landed by parachute in the inundated area near St. Germain de Varreville, France. Seeing a comrade struggling in his parachute in a canal, Corporal Taylor, ignoring the danger of enemy machine gun fire from nearby positions, and the danger of drowning in the canal, unhesitatingly plunged down the bank into the water and dragged the drowning man to the comparative safety of the bank. The furer caused by this rescue caused the enemy to fire on the three men engaged in the rescue with mortars as well as machine guns, but disregarding the risk involved, Corporal Taylor continued to render artificial resperation to his comrade until he regained consciousness. In a later operation, - Corporal Taylor was mortally wounded. His actions were in accordance with the highest standards of Military Service.

Dear Miss Taylor,

Introducing myself as: Captain Champ L. Baker, your brother's Company Commander, of Company "I" 502 Parachute Infantry.

I received your letter of 11 October, but unfortunately, censorship regulations have prevented me from replying as soon as I would have liked. As a matter of fact, I am still limited as to what I can tell you. Perhaps later I can be more specific and elaborate in detail of Lester's passing.

It is awfully hard for me to put down on paper how I feel about the men of my Company who have gone. And especially Lester. He was a member of my platoon nearly two years ago when I commanded the second platoon of "I" Company. I watched him develope from a civilian into a soldier, you might say, during that time, and I learned to place the utmost confidence and trust in him.

During the harrowing days following the invasion of Normandy, when our Company was torn to bits (though we inflicted terrific losses on the enemy), Lester's coolness and calmness under heavy fire stood out, and he was promoted to Corporal on the field of battle. Upon our return from France his efficient handling of our new men and his evident desire to transfer his knowledge to them gained on the field of battle resulted in his promotion to

Sergeant on the day we left for the invasion of Holland.

I cannot disclose the location of our jump in Holland or list any names of any type. We jumped on the 17th, and Lester was killed in action on the 19th. Our Company, after one day's heavy fighting, had been given the mission of defending a very important road block which would deny an avenue of supply and re-inforcements to the enemy we had trapped the day before. This very important mission was given to the second platoon commanded by Lt. Robert G. Burns. They went into position at 10.30 the night of the 18th, and at 2.50am were heavily attacked by a German column. In the face of terrific fire, the equal of which I have never seen, they held their ground and massacred the enemy attempting to break through. We killed many of them and took thirty-seven prisoners. Lester's squad, on the right, by it's display of bulldog tenacity and his personal leadership, refused to be pushed from the road block. His men held fast and the enemy was forced to retreat.

The next day (19th) the enemy again attempted to push through and once more were repulsed with heavy losses. The fighting raged around the road block all morning, and the ferocity of the action necessitated my sending up sorely needed reserves. At approximately 10.00a.m. Lester, seeing the need of more men on the other side of the road, proceeded across the road with two of his men to go to the aid of our troops there. He was struck down by machine qun fire and his death was instantaneous. His passing was merciful,

and he suffered no prolonged pain.

For his outstanding work in the face of the enemy and his utter devotion to duty he has been awarded the Bronze Star Medal posthumously. In due time you should receive this award from a grateful government. It may please you to know that by the road block's being held we were able to push forward later during the day and completely annihilate the enemy, taking over 900 prisoners and killing many.

I know this information is not as complete as you would like it, and later on when censorship permits I shall endeaver to ease your grief and pain at his loss with more specific details. Lester was one of my boys and his loss is very precious to me. I shall never be able to replace him, and in the coming years of peace I shall often think of him and the courageious manner in which he performed his duties under fire. His bravery and determination ranked beside the highest heroes of this war.
